MESSAGE FROM THE *President*




Thank you for reviewing the 2020-2021 annual report for Garden City Community College. The 2020-2021 academic year was a unique experience as the COVID-19 pandemic continued to change our lives. Community colleges have long been known for being responsive and adaptive to changing needs. This past year has proven how adaptive and responsive that GCCC is to the changing needs of business and industry, as well as students and stakeholders. At GCCC, we implemented a mixed offering

of classroom delivery styles to suit all students' needs while prioritizing the health and safety of students, employees, and the community. Students met in socially distanced classrooms, fully online, and through hybrid methods utilizing both in-person and virtual instruction. While the year brought many unknowns, GCCC students persevered. Enrollment increased in comparison to previous semesters for both our fall 2020 and spring 2021 semesters. This was directly attributable to the hard work and dedication of GCCC faculty and staff who found innovative ways to persist and continue shaping new minds, even during trying times. GCCC's 101st Commencement was held via a hybrid format, allowing GCCC graduates to walk to the stage with their biggest supporters by their side.

The pandemic has brought about many new challenges, but with challenges come opportunities. Numerous opportunities and upgrades took place at GCCC during the 2020-2021 fiscal year. The full remodel of the sports medicine department was completed, bringing about brand-new, state-of-the-art athletic training rooms inside the Dennis Perryman Athletic Complex and Bronbuster Stadium. Additionally, the baseball stadium received eight new LED light poles. Both enhancements have been beneficial to the GCCC athletics program. The GCCC music department saw much improvement with the renovation of the Pauline Joyce Fine Arts Auditorium. Brand-new seating was installed along with new flooring and lighting, which allowed the resumption of musical performances at GCCC.

These and other significant happenings are featured in this yearly report, alongside key segment information about GCCC's financial effect on our community. Campus Reopening & COVID-19 MITIGATION MEASURES

Garden City Community College reopened its front doors to public traffic on July 6, 2020. Employees, students, and visitors were required to wear a face mask that covers their nose and mouth while on campus. This campus-wide initiative followed the state executive order signed by Kansas Gov. Laura Kelly.

The mask requirements continued through the fall semester, with a few modifications. Masks were still required for all in class-

room and learning environments and student life programming events held indoors, however, masks were appreciated elsewhere indoors on campus.

The GCCC COVID Committee continued to monitor and assess new information and data to determine the operation phase weekly.

VACCINE INCENTIVE

GCCC encouraged all employees and students to get vaccinated and provided a \$500 fi-

nancial incentive for on-campus students, faculty, and staff who submit an immunization card showing they're fully vaccinated. Employees and students had to be fully vaccinated by the end of October to be eligible. The incentive will be applied to student accounts and employee payroll in November.

GCCC hosted vaccine clinics monthly on campus in coordination with the Finney County Health Department (FCHD). The

top priority of Garden City Community College remained the safety and health of students, staff, and the community. GCCC asked everyone to continue to be vigilant and help decrease the spread of COVID-19 by washing hands, social distancing, wearing a face mask in public places, and staying home if you are not feeling well.

Enhanced cleaning and sanitization across campus, alternative classroom formats to facilitate social distancing guidelines, self-health monitoring tools, and installation of protective equipment in meeting areas were just some of the key ways GCCC maintained a healthy and safe campus for the remainder of the summer and fall.

ADJUSTED CLASSROOM DELIVERY OPTIONS

Like many colleges and universities across the nation, GCCC had to get creative and flexible in order to maximize the health and safety of students, employees and campus visitors. During the summer and fall of 2020, GCCC offered a mix of classroom delivery styles.

Summer courses were moved to online and remote course delivery and students were offered a discounted tuition rate. Normally, GCCC students pay \$150 per credit hour for online courses, which includes tuition, fees, and online textbooks, however, through the summer term -- May 26 through August 7, 2020 -- tuition rates were \$108 per credit hour.

This cost reflected a total of the per-credit-hour tuition rate (\$61) and fees rate (\$47) for in-state students during 2019-2020. The discount net GCCC students a savings of \$42 per credit hour.

GCCC President Dr. Ryan Ruda said he was hopeful the savings would allow students to continue working on their educational

goals, while easing some of the financial burdens that students and their families faced in the wake of the COVID-19 pandemic.

"As we continue our efforts to mitigate the spread of the novel coronavirus, we've had to make many difficult decisions that affect the lives of our students and our employees," he said. "At GCCC, students are the number one priority. Through that, our goal is to make sure our students have the opportunity to progress toward degree and certificate completion without significant delays or severe financial hardship."

A unique feature that sets GCCC apart from many other institutions is that the cost of textbooks is included in its tuition/fee costs. Through GCCC's partnership with Cengage, students have immediate and convenient access to e-textbooks and know their costs up front.

The \$108 per credit hour rate applied to all GCCC students taking summer courses, including border-state and out-of-state students. It also applied to students attending other institutions who took summer classes at GCCC for transfer to their home college or university.

The fall semester also looked quite different. New course delivery options included fully on-ground courses, fully online courses, and at least four other hybrid course options that utilized both face-to-face instruction coupled with online learning, according to Vice President for Instructional Services Marc Malone.

In addition to these flexible start dates, students had the option to choose to customize their schedules in a way that best fit their educational and health needs in the wake of the COVID-19 pandemic.

"We have a fall semester that

looks unlike any fall semester in 100 years at GCCC, but through that struggle, we've worked to balance health and safety with opportunities for high-quality learning," Malone added.

To continue to keep the students, staff and faculty safe, GCCC paused most all face-to-face instruction on Nov. 20, 2020 prior to a week-long Thanksgiving holiday (Nov. 21-29). Most courses, with the exception of a few technical programs, resumed online starting Nov. 30 through Dec. 4, 2020, with finals week scheduled from Dec. 7-10, which was held remotely for most students.





Student Laptop *Loan Initiative*

GCCC offered over 100 new laptops at no cost to students who needed reliable computer access for their studies.

As GCCC students were forced to transition to online learning in late March due to COVID-19, lack of access to quality computer and internet technology for many at-risk students became apparent to administrators and faculty.

"At GCCC, we want to set students up for success and make sure they have the tools necessary to reach their academic goals," Dr. Ruda said. "We are hopeful offering reliable and portable computer access will lessen some of the financial burden that many of our students and their families are facing."

Funding for the laptop initiative was made possible by the Coronavirus Aid, Relief, and Economic Security (CARES) Act and the Higher Education Emergency Relief Fund (HEERF).

The total cost of the laptop initiative was under \$75,000. GCCC received about \$1.36 million in funding from the CARES Act and HEERF-Minority Serving Institution funds, just under half of which was distributed to eligible students as direct emergency grants.

CARES Act *Offers Relief to Students*

The Coronavirus Aid, Relief, and Economic Security (CARES) Act signed into law on March 27, 2020, created education stabilization funds available through the Higher Education Emergency Relief Fund (HEERF).

GCCC was tasked with distributing these funds (\$641,003) directly to students as emergency financial assistance to help cover expenses and alleviate financial hardships related to the disruption of campus operations in the wake of COVID-19.

In addition to CARES Act assistance, a small amount of institutional funds were set aside for any GCCC student experiencing financial hardships stemming from the COVID-19 crisis.

March 23, 2021 -- Garden City Community College announced the 2021-2022 Ambassador Scholars: Anjelina Serrano of Garden City, KS and Heidy Mercado of Liberal, KS.

An Ambassador Scholar is a prestigious scholarship accolade based on academic achievement, school and community service, and other important criteria. This award is given to two incoming freshmen each year at GCCC. Each applicant must be recommended by a counselor from their high school, submit a comprehensive application, and complete a thorough personal interview process. Ambassador Scholars receive a \$1,500 annual scholarship awarded for their two-year term. The Ambassadors assist the President's Office and the Endowment Association Office throughout the year with various tasks and events on campus.

"Our new Ambassador Scholars are outstanding. Ms. Serrano and Ms. Mercado demonstrated remarkable success in their previous activities and involvement, and I look forward to watching their accomplishments continue here at GCCC." Dr. Ruda, GCCC President, said. "One of the prime advantages of attending a college the size of GCCC is that a student can participate in various activities and learn leadership responsibilities. Campus involvement allows a student to expand their interpersonal skills while obtaining their education."

Anjelina Serrano of Garden City, Kansas will soon graduate from Garden City High School. Serrano holds a 3.4 GPA while participating in softball and wrestling while working at Walmart. She achieved the distinction of being the first-ever girl named to the Wrestling Wall of Fame at GCHS. She has already earned her CNA certification from GCCC along with many dual-credit courses. Serrano plans to earn an Associate in Applied Science Degree in Nursing from GCCC and hopes to work on the NICU and/or OB-GYN hospital floor.

Heidy Mercado of Liberal, Kansas will soon graduate from Southwestern Heights High School. Mercado holds a 3.9 GPA while participating in volleyball, basketball, softball as well as being a member of choir, pep band, band, and FCCLA. She is a member of the National Honor Society and currently holds the offices of Band President and Secretary of Choir. Mercado also works as a CNA and plans to major in Nursing at GCCC.

Nursing Program **EARNs HIGH MARKS**

Spring 2021 -- The Garden City Community College Nursing Program ranked as one of the top 100 schools in the Plains region according to the Nursing Schools Almanac.

"It's quite humbling to be honest," Director of Nursing, Patsy Zeller said. "A lot of our success is predicated on our great faculty and staff. They're the ones in the trenches."

The program, which boasts the top practical nursing curriculum in the state, was ranked 99th overall and the third best Community College in the region.

"This external validation confirms what we know to be true about the GCCC nursing program," College President, Dr. Ryan Ruda said. The program offers several options for future healthcare professionals, including a certified nursing program, an associated of applied science degree in registered nursing, and a practical nursing certificate. The AAS degree

and LPN certificate programs each graduate approximately 20-30 students annually. In addition, students have achieved an 86 percent NCLEX-RN pass rate and a stellar 98 percent NCLEX-PN pass rate; both are above the six-year average for any school in Kansas.



Dual Credit AUTO TECH CLASSES Easier to Access

GCCC began offering tuition-free dual credit Automotive Technology courses to high school students from Garden City, Deerfield, and Holcomb starting in Fall 2021 at the Garden City High School campus.

High school students interested in training for an automotive technology career, getting a foot in the door with local auto shops, and receiving personal attention from an instructor are encouraged to start earning their industry certificate now.

In addition to Automotive Technology, GCCC offers several other career technical education (CTE) courses and programs to high school students and Senate Bill 155 made these dual credit courses virtually FREE* - AND BOOKS are INCLUDED!

In order to make these courses more accessible, they are available in a number of ways -- Online, via Zoom, on high school campuses or on the GCCC campus.

GCCC Signs Articulation Agreement with Bethany College

Special Tuition Structure for Finney County Residents

The Board approved a new tuition structure for Finney County residents that will create a Finney County resident tuition rate. Currently, Finney County residents are included in the in-state tuition rate. **Starting in Fall 2021** with this new status, tuition will be **held flat at \$61 per credit hour for Finney County residents**. This starts the process of being able to have a tuition structure which benefits county stakeholders and taxpayers. GCCC is proud of this new initiative and hopes to further advance this benefit for local residents.

Enrollment Growth DURING FALL SEMESTER

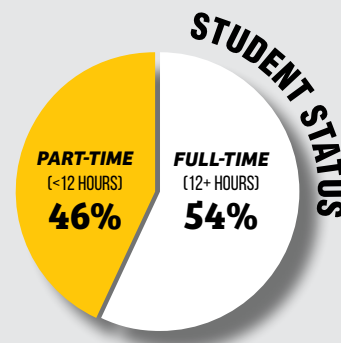
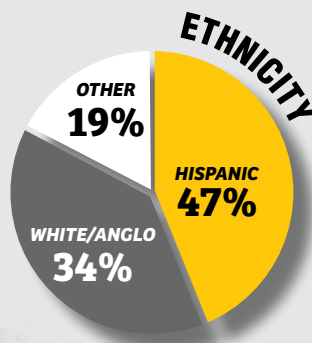
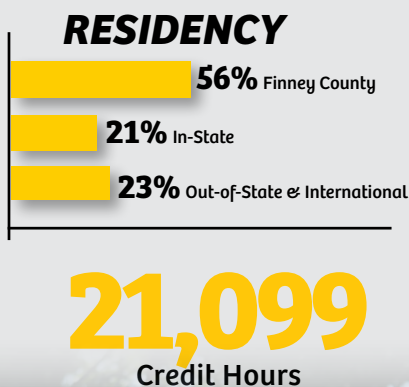
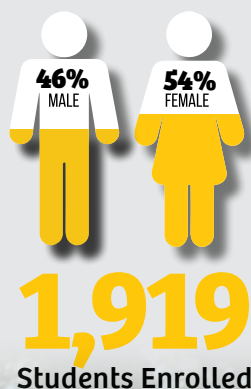
Garden City Community College announced that enrollment for the fall semester, as of Oct. 1, was up .3 percent compared to the same time last year.

"GCCC has been very intentional in their efforts and focus on enrollment, and this is directly attributed to the faculty and staff at GCCC who place the highest importance on students, student engagement, and the student experience," Dr. Ryan Ruda said in a statement.

These numbers are in contrast to a report released by the Kansas Board of Regents that showed that the Kansas Community College system experienced a

sharp decline in enrollment for the start of the fall semester, which directly correlated with the COVID-19 pandemic. The preliminary report from KBOR represents enrollment as of Sept. 14 at institutions. The report is indicative of the disruption that all K-12 schools in the state experienced back in March as a major contributor to the downturn, stating that because students had transitioned into distance learning, it hindered the assistance they would have normally received to enroll in fall classes and dual-credit courses.

GCCC'S JOHN DEERE AG-TECH PROGRAM EARNS *Platinum* AWARD

Garden City Community College's John Deere Agriculture Technology (JDAT) program earned the highest ranking of Platinum Level for the 2020 College of Tomorrow award.

The John Deere College of Tomorrow (COT) award is a tracking system designed by the industry leader to measure the success of JDAT programs across the nation. The scoring system is designed to cover a gamut of areas that measure the ability of an institution to effectively teach technicians who are new to the workforce.

This award, based on the 2020-2021 academic year, is a prestigious honor given to John Deere training programs across the nation with rankings of Bronze, Silver, Gold, and Platinum levels. Each program is evaluated and graded on several factors, including internship communications and connections to businesses. Last year, the GCCC JDAT program was awarded a Gold Level ranking of the COT award.

Gabe Winger, GCCC's lead John Deere instructor, said part of the merit-based award is due to the changes and upgrades that the program has made in the last few years with the support of the college. The associate's level program at GCCC prepares students for a position with a local John Deere dealer upon successful program completion.

Governor Kelly Signs CTE Proclamation at GCCC

February 23, 2021 -- Kansas Governor Laura Kelly signed a proclamation declaring February as Career and Technical Education (CTE) month during a visit to the Garden City Community College campus on Tuesday, February 23rd.

The visit began with a campus tour, highlighting two of GCCC's technical programs. Dr. Clint Alexander, Animal Science Instructor/Meat Judging Coach, demonstrated equipment in the GCCC Meat Lab and shared details of the program including processing, fabrication, and packaging of meat products with the Governor and her team.

The next program to be highlighted was one of GCCC's newest, Industrial Machine Mechanic. Cory French (pictured with Governor Kelly to the right), Industrial Maintenance Instructor, discussed the training partnerships which allow GCCC to offer machine-specific learning to local industry partners' employees. "The significance of technical education is far-reaching, not only in a student's education but in the impact specialized career training has on our community," Dr. Ruda said. "GCCC's mission is easily

accomplished by our technical education programs, which provide valuable skills and industry-specific knowledge".

Governor Laura Kelly then spoke about the significance of technical and career training. "Here in Kansas, our colleges and universities play an essential role in our state's continued success. They take a dynamic approach in driving, innovating, and creating jobs for the next generation." She discussed the need for workers trained in essential front-line careers and technical education. Governor Kelly stated that GCCC provides career and technical education training which prepares students for immediate readiness to enter the Kansas workforce.

The proclamation declaring February as Career and Technical Education month was signed by Governor Kelly. This decree emphasized the importance gained from career and technical education.

Garden City Community College was honored to host Governor Laura Kelly on campus, and we thank her for her continued work and dedication to Kansas community colleges, as well as her support of the Excel CTE program for high school students throughout the state.

State Tax Credits allow GCCC to Purchase Anatomage Tables

June 23, 2021--Through a *Kansas Department of Commerce tax credit grant*, GCCC secured over \$186,000 from donors to purchase two high-tech Anatomage tables as well as other equipment and learning resources to complement the tables.

The tables, provide three-dimensional, high-resolution mapping of both human bodies and select animal cadavers which allows students with a hands-on learning environment that is generally more precise than traditional cadaver labs.

The tables will be utilized by GCCC students through Anatomy and Physiology courses as well as area high school science departments. The portable equipment will be loaned to local high schools on a rotating basis to share the educational technology with high school students interested in the STEM fields, which enhances the teaching process and learning outcomes.

ONLINE FOOD SAFETY PROGRAM RECOGNIZED BY USDA

The United States Department of Agriculture recently recognized the Garden City Community College Online Food Safety Program for its training and leadership.

"The ability of our program to find very qualified adjunct faculty members that can take extremely complex information and disseminate it to inspectors around the country at an affordable cost is what sets this program apart," said Dr. Clint Alexander, animal science instructor and the director of Buster Red Meats.

The program, which is currently in its third year, is available for students across the country and utilizes five adjunct professors. It's aligned in a partnership with the USDA using an online curriculum and has serviced some 400 consumer safety inspectors since its inception in 2018. It's a very diverse program with 70 percent of its students coming from minority backgrounds.

Two Grants for Welding & Buster Red Meats

Oct. 21, 2020 - GCCC secured two new grants from the **Kansas Department of Commerce** totaling **\$335,000** to help purchase four virtual welding simulators and a refrigerated truck for the Buster Red Meats program.

According to statistics provided by Workforce One, unemployment numbers in advanced manufacturing have spiked since March with more than 300 jobless claims being reported. To help mitigate this disturbing trend, **GCCC secured a \$235,000 Higher Education Advanced Manufacturing Grant to purchase four RealWeld Training simulators. This new piece of technology will al-**

low college and high school students across the area to practice Stick, MIG and Flux-Cored arc welding, while receiving audio coaching and weld performance tracking.

"This is a tremendous addition to our welding program," Dr. Ruda emphasized. "The plan is to advance training in the field."

Meantime, the **\$100,000 Local Food Systems Grant will help subsidize the purchase of a state-of-the-art, refrigerated truck allowing for increased capacity and safe delivery of meat products to local retailers.** It also includes an automated patty machine to increase capacity of processed products to market, a

vacuum packager to efficiently and safely package products, and an upright freezer for campus/community food pantry to increase access.

"This grant will help the program be more productive and efficient," said Dr. Clint Alexander, Director of Buster Red Meats. "During the pandemic, finding processing appointments for livestock to be harvested locally has become challenging. We hope to remedy this by expansion of freezer storage as well as a harvest facility."

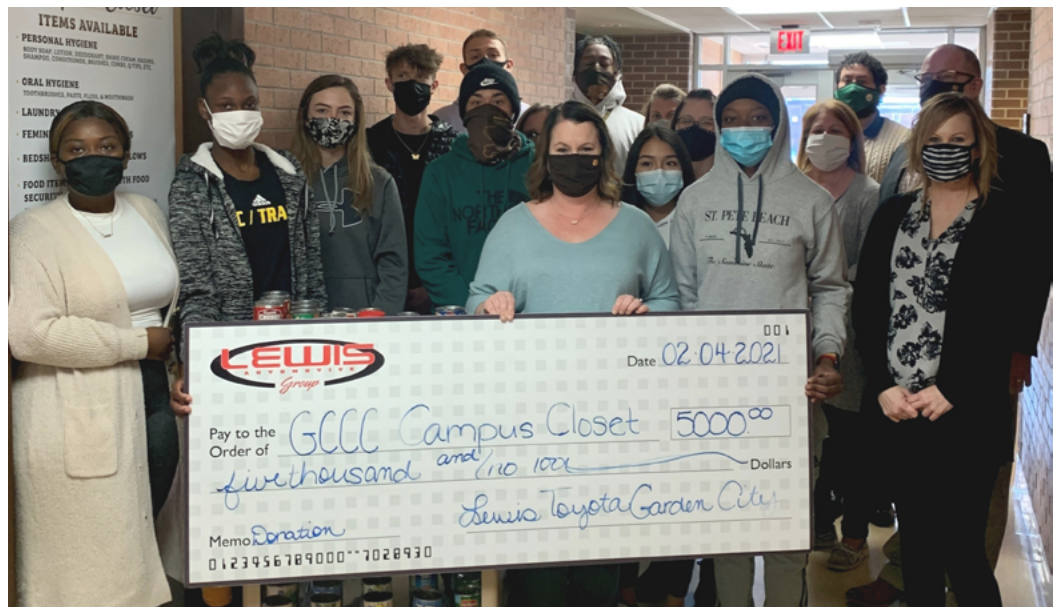
The \$5,000 grant was made possible through the Toyota Dealership Association Grassroot Marketing

Through this grant, **Tyson will invest an initial \$10,000**

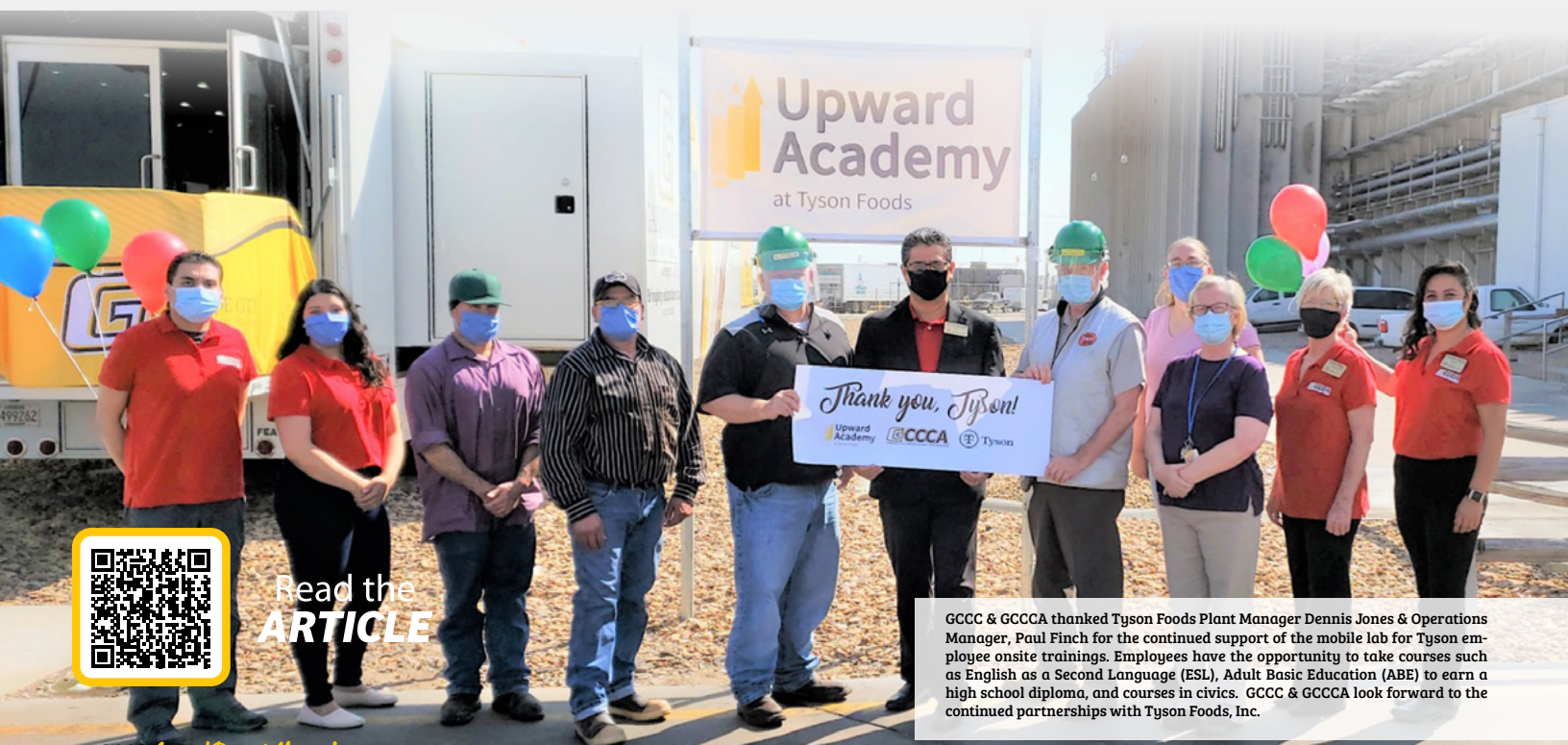
to fund the educational cost of program participants at GCCC. Other initiatives are underway to procure additional grant dollars to help increase and advance this partnership further.

April 23, 2021 -- Garden City Community College was excited that Governor Kelly signed the Kansas Promise Scholarship Act, a last-dollar scholarship program for Kansas high school graduates who complete a CTE certificate or two-year program in specific career and technical education (CTE) programs.

House Bill 2064 established the Kansas Promise Scholarship Act which provides scholarships for students to attend an eligible postsecondary institution for any two-year associate degree program, career and technical education certificate, or stand-alone program otherwise identified by the Kansas Board of Regents.

"This is fantastic news that will increase pathways for students to access higher education. We are excited that this program will make technical education more attainable for Kansans," Dr. Ruda, GCCC

President, said. While specific details are still forthcoming, GCCC is actively working to create plans for this program, which will be implemented in the Fall 2021 semester.

"This act is designed to address the rising cost of college and decades of pushing students into programs that don't fit the needs of our state's workforce. The Kansas Department of Commerce in conjunction with members of business and industry in our state will identify high-need areas for semi-skilled labor. Any Kansas high school or home school graduate who agrees to go into one of those fields will receive a Kansas Promise Scholarship to pay for attendance at a Kansas trade or tech school or community college. Students will have work requirements during school, and residency requirements after school," Rep. Joe Seiwert (R-Pretty Prairie) said in a newsletter.

Who is Eligible?

ANY KANSAS RESIDENT who is taking 6 credit hours or more, who meets income requirements

AND

HAS GRADUATED from a **KANSAS HIGH SCHOOL** or **OBTAINED GED** within the last 12 MONTHS*.

OR

IS 21 YEARS OF AGE OR OLDER and has been a **KANSAS RESIDENT** for **AT LEAST 3 CONSECUTIVE YEARS**

OR

IS a DEPENDENT OF A MILITARY SERVICE MEMBER who is permanently stationed in another state **AND** who **GRADUATED FROM AN OUT-OF-STATE HIGH SCHOOL**, **OBTAINED A GED OR HIGH SCHOOL EQUIVALENCY** **WITHIN IN THE LAST 12 MONTHS***.

Athletic Training Remodel

Aug. 26, 2020 -- For months, the sounds of drills, backhoe loaders and hammers, infiltrated the Perryman Athletic Complex and Broncbuster Stadium. And after nearly a half year's work, the full remodel on the brand-new, state-of-the-art sports medicine department at Garden City Community College was finally complete.

"I am absolutely thrilled with the outcome of the renovations," Head Athletic Trainer, Allison Griffin said. "Those facilities are truly something out of my dreams. Our contractors, construction, facilities and maintenance staff have done incredible work putting all of this together."

The \$491,000 project was offset by a \$300,000 grant from the Sunderland Foundation, a company based in Overland Park, KS that annually makes grants to charitable and non-profit organizations for construction and special-interest projects. The gift was directed through the GCCC Endowment Association, a private fundraising arm of the community college and a 501 (c) (3) organization, which also served as the grant applicant for this project.

The project involved renovating both the athletic training room inside the Perryman Athletic Complex

and the one located out at Broncbuster Stadium. The facilities are now equipped with new treatment tables with leg and back rests on gaskets to allow for specified treatments, treatment carts and stools, therapeutic modalities with electrical stimulation, whirlpools, ice machines and iPads with docking stations for daily sign ins. The room at the football stadium, which doubles as a visitor's locker room, has been totally redesigned with fully operational showers.

This is the first major renovation for the athletic training facility since it opened in 1985.

"This project allows us to tremendously increase the academic experience for both our athletic training and exercise-science students," President Dr. Ryan Ruda said.

Broncbuster Fitness Center Upgrades

Also part of the Athletic Training upgrade project, Broncbuster Fitness, more affectionately known as the Super Circuit inside the Perryman Athletic Complex, was also improved and upgraded.

The fitness center has served as a workout facility for students, employees, and community members for years. So, it was only natural that the administrative team at Garden City Community College reinvest in one of its major assets.

Now, after months of planning and preparation, the facility is sporting some new, state-of-the-art machines that completely modernizes the space.

"This whole process has been very exciting," long-time Super Circuit Director, Greg Greathouse said. "Our goal is always safety first, and with this new equipment, we are able to maintain those protocols across the board."

The facility upgrade also included all new workout equipment which was purchased through approved student fees, making the facility free of charge to all students currently enrolled at the college.

The area now features two dual adjustable pulley machines, Hammer Strength series that works all body parts, a chest and shoulder press, lat pull, row machine, hamstring, quad and leg press, three new recumbent bikes, an arc trainer, power mill, spin bikes with 'My Ride' to customize the user's experience, five ellipticals, and five new treadmills. Also, one of the newest innovative features is the ability for users to watch television and listen to the audio through their own personal headphones.

Land on All-Conference Team

Jun 04, 2021--Despite only playing eight games, the fewest since 1949, the Broncbusters placed 13 players on the All-Conference squad this week, led by first teamers Jordan Ford, Raymond Cutts, Arvell Ferguson Keylon Kennedy, and Jonathan Huggins.

"Considering everything, we had a good spring," Head Coach, Tom Minnick said. "Our goal every year is to win the National Championship. We gave ourselves a chance in that regard."

Ford may have been the best kept secret in the NJCAA. After seeing minimal time as a freshman, the Georgia native burst onto the scene in 2021, becoming the second Broncbuster running back in the last three years to win the rushing title. The sophomore totaled 1,039 yards and 12 touchdowns,

surpassing the century mark five times including a career-best 222 in a 52-40 victory over Butler in the spring finale.

Ford wasn't the only one making headlines. Safety, Jonathan Huggins, played in only four games before injuring his arm, was the leader of Jerry Dominguez's vaunted defensive unit. The University of Florida transfer tallied 24 tackles including eight for loss and had one fumble recovery. He recorded a season-high eight stops in the Broncbusters 14-10 come-from-behind win over Independence on Apr. 17.

Joining Huggins on the All-KJCCC defensive first team was lineman Raymond Cutts, who finished the season with 32 tackles and a team-best 4.5 sacks. The Central-Florida transfer was fourth in the league

in quarterback takedowns and 23rd in stops. He teamed up with Ferguson, who tallied 29 tackles, seven for loss, a forced fumble and three pass breakups. Those two along with defensive back Keylon Kennedy, who became one of the best cover corners in the Jayhawk Conference, spearheaded one of the top defenses in the country. The sophomore, who was an All-MIAA performer at Fort Hays State before transferring to Garden City, had 15 tackles, two forced fumbles, a fumble recovery and one breathtaking red-zone interception vs. Independence.

"Our defense was consistent all season," Minnick said. "And we were shorthanded for a few games, which makes the job those guys did even more impressive."

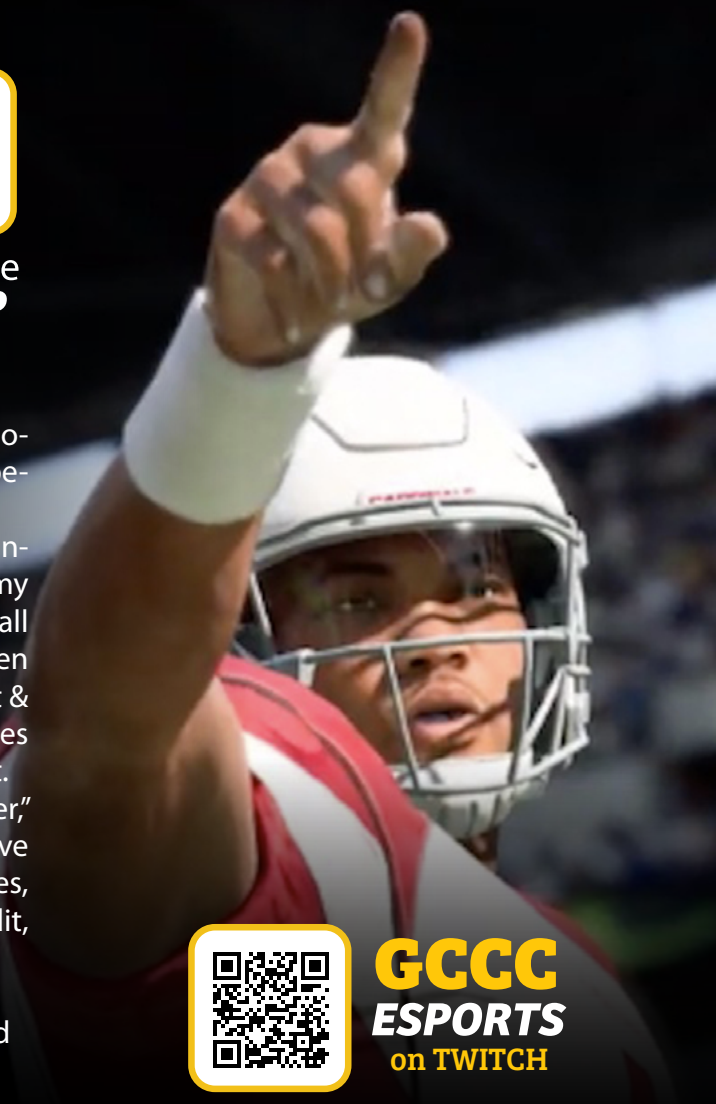
"I don't think people realize how fun playing video games

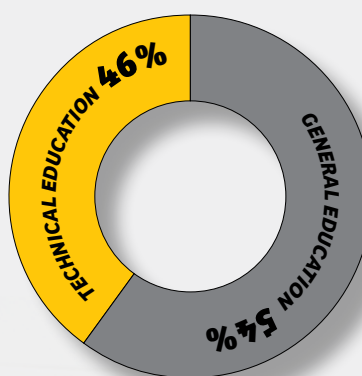

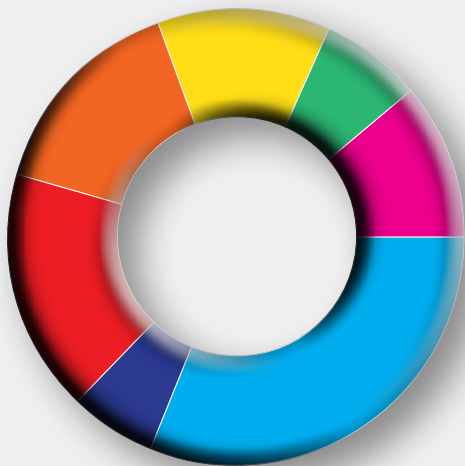

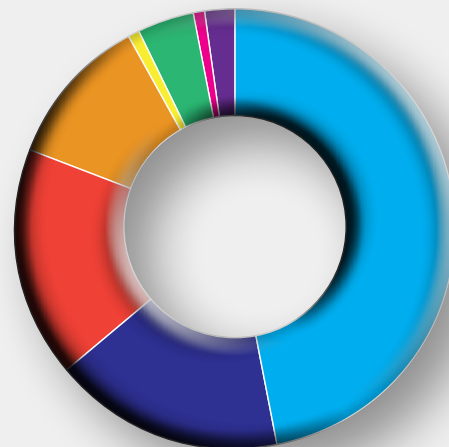

Businesses throughout the region gave items to be auctioned and our donors responded by bidding generously throughout the online event. In addition, many substantive direct financial gifts were made by businesses and individuals alike as a direct result of the auction. The

auction proceeds ensured that we could meet our scholarship obligations for the year.

"While we are disappointed to be unable to hold our traditional auction for the second year in a row, the opportunity to allow individuals from outside our area and across the country the chance to participate is great," Executive Director, Jeremy Gigot said. "We hope to return to our in-person auction next year, but in the meantime, we welcome anyone to participate in helping us raise scholarship funds for GCCC students!"



Mary Jo Williams Grant AWARDS FOUR GCCC Programs & Departments

The Mary Jo Williams Charitable Trust chose to fund four grant requests from GCCC faculty and staff totaling over **\$63,000**.

The 2020 recipients and projects were:

1. The *Mary Jo Williams Comprehensive Learning Center* requested **\$19,206.40** to purchase and install eleven (11) additional private study cubicles and to purchase five (5) study tables to replace tables that have reached the end of their useful life.
2. The *GCCC Auto-Tech Program* requested **\$18,168** to purchase two (2) brake lathe Kits. These brake lathes will be utilized by students enrolled in the college program and high school students enrolled in outreach programs in USD 457 (Garden City) and USD 363 (Holcomb).
3. The *Carpentry Program*, the newest technical program on the GCCC campus, requested **\$6,808** for the purchase of a SawStop table saw with a 52" industrial t-slide and a large sliding table. This will greatly enhance the safety and educational opportunities of the students enrolled in the program.
4. The *Counseling and Advising staff at GCCC* requested **\$19,747.65** for the purchase of 68 100e Google Chromebooks for the use of the advising staff. The Chromebooks will allow our 58 advisors to assist students as they utilize our online systems to register, enroll for classes, view billing and financial aid information and track their progress toward degree completion.

The Mary Jo Williams Charitable Trust was established 1986. Garden City Community College Endowment Association was one of the first beneficiaries of the Mary Jo Williams Charitable Trust, and the Trust has provided over \$1.8 million in grant and scholarship funding which has assisted in the enhancement of educational opportunities at Garden City Community College.

The initial gifts were utilized to start the Mary Jo Williams Comprehensive Learning Center in the GCCC Library, and the Trust has continued to provide funding for a grant request project each year. Nearly every program on the GCCC campus has received a grant for the purchase of technology, educational materials, or equipment. The grant requests are submitted by GCCC employees for up to \$20,000 and are for educational equipment and materials, educational access and student success, promotion of the arts, or student services.
